The meeting was called to order by council president Jerry Frankenfield.

Old Business

 - 1. SKL's Pr. Karen Soli will be coming to St. Paul's this September.
 - 2. This program will assist our council members and congregation with fundraising for both the Hardison property purchase and future programs at St. Paul's.
 - 3. St. Paul's *Vision* and *Goals* must be determined before the SKL program begins.
 - 4. Donna Frederick will distribute SKL information booklets to all council members who haven't already received them.
- C. Debbie Cowell will distribute the newly developed *job descriptions* to all new council members.
 - a. Copies of all committee chairperson job descriptions will be filed in the St. Paul's archives and the office computer.
- D. The Evangelism committee still needs a chairperson.
 - a. Committee members may rotate attendance at future council meetings until a chairperson can be found.

New Business

- A. Jerry Frankenfield passed around a paper for council members to list their email addresses and the date each one started on council.
- B. Randy Arndt pointed out that, because the previous council did not find a replacement to complete vice president Pete Snyder's unfinished term, but rather recommended that the congregation elect Diane Winn to a full term, both

president and vice president positions will now be scheduled for replacement at the same time.
